



2010-2011 RESERVE MEMBERSHIP

Reserve membership is intended for persons who have been active members but who are no longer eligible for active membership. For example, you are eligible for reserve membership if you:

- ◆ *Are on unrequested leave of absence or have been laid off from employment with a district or other educational institution where you were an active member.*
- ◆ *Are on a leave of absence (voluntary or involuntary) from employment with a district or other educational institution where you were or could have been an active member.*
- ◆ *Terminated your employment (voluntarily or involuntarily) with a district or other educational institution where you were an active member.*

To request legal or field staff assistance regarding your employment rights (e.g., recall from layoff or issues related to your leave of absence) or other issues covered by Education Minnesota's Legal Services Policy (e.g., licensure), you must maintain a reserve membership.

BENEFITS OF MEMBERSHIP - Reserve membership preserves full rights to all benefits including:

- ◆ *Employment related legal services*
- ◆ *National & State member services programs*
- ◆ *Field staff assistance*
- ◆ *National and State publications*

- 3/4 DUES – Reserve Dues are \$524.30
- 1/2 DUES – Reserve Dues are \$332.50
- 1/4 DUES – Reserve Dues are \$190.35
- 1/4 DUES and – Reserve Dues are \$112.85
earned under \$1,654 annually

Educational Support Professional – If you paid active:

- FULL DUES – Reserve Dues are \$616.80
- 3/4 DUES – Reserve Dues are \$520.70
- 1/2 DUES – Reserve Dues are \$325.35
- 1/4 DUES – Reserve Dues are \$179.60
- 1/5 DUES – Reserve Dues are \$157.85
