



2011-2012 RESERVE MEMBERSHIP APPLICATION

Reserve membership is intended for persons who have been active members to continue membership when they are no longer eligible for active membership. For example, you are eligible for reserve membership if you:

- ◆ *Are on unrequested leave of absence or have been laid off from employment with a district or other educational institution where you were an active member.*
- ◆ *Are on a leave of absence (voluntary or involuntary) from employment with a district or other educational institution where you were or could have been an active member.*
- ◆ *Terminated your employment (voluntarily or involuntarily) with a district or other educational institution where you were an active member.*

You must purchase an Education Minnesota reserve membership prior to your active membership ending to qualify for legal or field staff assistance regarding your employment rights (e.g., recall from layoff or issues related to your leave of absence) or other issues covered by Education Minnesota's Legal Services Policy (e.g., licensure).

BENEFITS OF MEMBERSHIP - Reserve membership preserves full rights to all benefits including:

- ◆ *Employment related legal services*
- ◆ *Field staff assistance*
- ◆ *National & State member services programs*
- ◆ *National and State publications*

DUES FOR 2011-2012 - Unified national and state dues are required. Please check the appropriate level based on your active employment immediately preceding your resignation, termination or leave of absence. If you have been a member during the 2011-2012 membership year, your previous payments will be credited.

Professional – If your contracted FTE is:

- FTE .76 - 1.0 Reserve Dues are \$623.40
- FTE .51 - .75 Reserve Dues are \$530.90
- FTE .26 - .50 Reserve Dues are \$335.80
- FTE .25 or less.... Reserve Dues are \$192.00
- FTE .25 or less.... Reserve Dues are \$114.50 and earning under \$1,690 annually

Educational Support Professional – If your contracted salary is:

- EARNING \$33,791 AND overReserve Dues are \$490.40
- EARNING \$25,343 TO \$33,790 ..Reserve Dues are \$431.40
- EARNING \$16,896 TO \$25,342 ..Reserve Dues are \$269.80
- EARNING \$7,434 TO \$16,895Reserve Dues are \$151.50
- EARNING under \$7,434Reserve Dues are \$137.50
